BOARD OF EDUCATION MEETING MINUTES

Wamego Public Schools

July 15, 2019, 7:00 p.m.

1. ROLL CALL

President Cory Meyer called the regular meeting of the USD 320 Board of Education to order at 7:00 p.m., Monday, July 15, 2019 at the USD 320 Professional Learning Center. Members of the board present were Bruce Coleman, Ryan Hargitt, Michele Johnson, Cory Meyer, Rob Pettay, Sheryl Wohler, and Nicolette Zeigler. Also present were Superintendent Tim Winter, Board Clerk Kathryn Mayfield, Operations Director Larry Hannan, WHS Vice-Principal Dennis Charbonneau, and WMS Vice-Principal Brian McIntosh.

2. PLEDGE OF ALLEGIANCE

The meeting began with the Pledge of Allegiance led by Rob Pettay.

3. RESOLUTION TO EXTEND TERM OF BOARD OFFICERS

Rob Pettay made a motion to adopt the resolution hereby extending the terms of the current president and vice-president until successors are elected in the 19-20 calendar year. Ryan Hargitt seconded. Motion carried 7-0.

Cory Meyer elected to president.

Ryan Hargitt elected to vice president.

Mr. Winter updated the board on recent strategic planning and MTSS meetings.

At 8:35 p.m., President Cory Meyer called for a five-minute recess.

Meeting resumed at 8:40 p.m.

20. EXECUTIVE SESSION (8:40 pm)

Bruce Coleman made a motion to go into executive session to discuss proposals for increasing base pay rates for certified staff pursuant to the exception for employer-employee negotiations under KOMA, to invite the Superintendent into executive session, and to resume the open meeting in the boardroom at 8:50 p.m. Sheryl Wohler seconded. Motion carried 7-0. Meeting was recessed at 8:41 p.m. The board returned to open session at 8:50 p.m.

At 8:50 p.m., Ryan Hargitt made a motion to extend the meeting up to 30 minutes as allowed by board policy to 9:30 p.m. Nicolette Zeigler seconded. Motion carried 7-0.

Ryan Hargitt made a motion to go into executive session to discuss a personnel performance matter pursuant to the nonelected personnel exception under KOMA, to invite the superintendent into executive session, and to resume the open meeting in the boardroom at 9:20 p.m. Bruce Coleman seconded. Motion carried 7-0. Meeting was recessed at 8:51 p.m. The board returned to open session at 9:20 p.m.

Michele Johnson made a motion to adjourn the meeting. Bruce Coleman seconded. Motion carried 7-0. Meeting was adjourned at 9:21 p.m.
