## BOARD OF EDUCATION MEETING MINUTES

Wamego Public Schools  
August 17, 2018, 5:00 p.m.

### 1. ROLL CALL (5:00 PM)

President Cory Meyer called the scheduled meeting of the USD 320 Board of Education to order at 5:00 p.m., Friday August 17, 2018 at the USD 320 Professional Learning Center. Members of the board present were Bruce Coleman, Ryan Hargitt, Michele Johnson, Cory Meyer, Sheryl Wohler, and Nicolette Zeigler. Rob Pettay was not present at roll call.

Also in attendance were Superintendent Tim Winter, Clerk Kathryn Mayfield., Special Services Director Chris Cezar, Director of Curriculum Dr. Mary Kaye Siebert, Central Elementary Principal Teri Dow, West Principal Amy Flinn, Wamego Middle School Assistant Principal Brian McIntosh, Wamego High School Principal Chad Brecheisen, and Wamego High School Assistant Principal Dennis Charbonneau.

### 2. PLEDGE OF ALLEGIANCE

The meeting began with the Pledge of Allegiance led by Michele Johnson.

### 3. WAIVE LENGTH OF MEETING

Nicolette Zeigler made a motion to waive the length of meeting for this Board of Education meeting. Bruce Coleman seconded. Motion carried 6-0.

### 4. APPROVAL OF AGENDA

Bruce Coleman made a motion to approve the agenda as presented. Michele Johnson seconded. Motion carried 6-0.

### 5. BOARD RETREAT (5:04 PM)

President Cory Meyer gave a brief welcome and overview of the agenda.

Superintendent Tim Winter shared the District's Mission Statement, Vision and Commitments then began a review of the District Goals established for 2011-2016.

- Put old goals on hold and focus on KESA goals
- Move annual retreat to Spring
- Revise and write new goals after KESA review

At 5:25 p.m., Wamego Middle School Principal Travis Graber joined the meeting.

At 5:28 p.m., board member Rob Pettay arrived and joined the meeting.

At 5:57 p.m., President Cory Meyer call for a meal break.

Meeting resumed at 6:20 p.m.

Discussion moved on Math: Dr. Siebert spoke of the history of State adoption of Common Core, ACT and instructional strategies. All agreed that a curriculum review should be considered in the future.

At 7:30 p.m., a review of the district's SRO and his duties occurred. An overview of State required crisis drills for 18-19 was discussed at length along with annual ALICE (Active Violence Incident Response).

The board discussed re-developing drug and alcohol education curriculum within the next year.

At 8:12 p.m., President Corey Meyer called for a break. At 8:20 p.m., the meeting resumed.

Discussion continued with the subject of MS/HS activities, handbook language, the possibility for a reference guide for parents, review of legality issues. The board asked both ADs (Brian McIntosh and Dennis Charbonneau) to develop a reference guide for parents for review in the spring of 19-20.

Discussion of whether to implement team cuts due to funding, etc. was discussed.

At 9:15 discussion turned to fund raising procedures/policies and accountability. A new procedure and training book for coaches and sponsors was introduced.

Social media/communications with the public was the next item of discussion. The board expressed the need in the future for a person to be hired to fill that need.

At 9:26 p.m., Nicolette Zeigler made a motion to adjourn the meeting. Rob Pettay seconded. Motion carried 7-0. Meeting adjourned at 9:26 p.m.
