We must still go through the sped eligibility process. There is no federal funding for this new Kansas disability since it's a state initiative vs. a federal initiative, like Gifted Education. 
The GSI Corti™ is a portable, battery-operated diagnostic and screening instrument that measures

The referring staff provides high quality lesson plans and materials for ESY learning.

## Licensure

Summer IEP Audit: As part of the district fiscal audit, between 40-50 IEPs represented by all exceptionalities and all districts will be chosen for review. The Coop will be contacted about which IEPs will be selected for the summer audit. Diana will notify sped teachers/providers if any of your students are chosen for the audit and will give you specific directions at that time. As a reminder, please be sure your paper files are in order and complete ready for this audit.

Coop Check-Out: Call Robin to schedule your appointment. Check-out is required for all certified staff. Be sure to print out and bring a completed copy of the Coop End-of-Year Check-Out sheet with you to your check-out meeting. All Progress Reports must be completed and sent to families no later than the last day of school. Be certain all Progress Reports have been completed for every student for every grading period as indicated in the IEP for the whole year. We look forward to meeting with you to get these important pieces of special education paperwork completed so you can jump into your summer upon the completion of your full contract days.

Did you know.....We still have 185 IEP packets in process and unresolved as of today?! PLEASE be sure you get your IEP packets completed immediately and to the Coop. Reminder, all of this must be completed by your Coop check-out meeting time. Packet corrections that are needed within 10 days or less from the last day of school will not be sent to you to prevent packets from being delayed in delivery. These packets are held at the Coop for your completion during your check-out time and there will be a computer set-up for completing this. If you have not received a packet back, please contact the Coop to see where it is in the review process. We need ALL IEPs in ASAP to allow for ample time for a compliance check, your corrections of any errors if needed, and a final Coop review. Reminder, our IEP compliance team has members on teacher contracts and they will not be able to process IEPs once school is out. Your help is much appreciated! Teamwork makes the dream work! Together we can get this done so everyone can enjoy summer on time!

## IMPORTANT UPDATE ON DLM (Alternate Assessment) for 2023/24:

For the 2023/24 school year, students taking the DLM MUST take BOTH the fall and spring assessments to be counted for assessment participation for the year.
