BOARD OF EDUCATION MEETING MINUTES

Wamego Public Schools January 13, 2020, 7:00 p.m.

1. ROLL CALL (7:00 PM)

President Cory Meyer called the regular meeting of the USD 320 Board of Education to order at 7:00 p.m., Monday, January 13, 2020 at the USD 320 Professional Learning Center. Members of the board present were Bruce Coleman, Deb Long, Claudia McAlister, Cory Meyer, Terra Miller, Rob Pettay, and Sheryl Wohler.

Also in attendance were Superintendent Tim Winter, Clerk Kathryn Mayfield, Special Services Director Chris Cezar, Director of Curriculum Dr. Mary Kaye Siebert, Central Elementary Principal Teri Dow, West Principal Amy Flinn, Wamego Middle School Principal Travis Graber, Wamego High School Principal Kale Katt, Wamego High School Assistant Principal Dennis Charbonneau, Operations Director Rob Miller, and Technology Director Jared Brazzle.

2. PLEDGE OF ALLEGIANCE

The meeting began with the Pledge of Allegiance led by Rob Pettay.

3. APPROVAL OF AGENDA

Bruce Coleman made a motion to approve the agenda as presented. Rob Pettay seconded. Motion carried 7-0

4. INTRODUCTION OF NEW BOE MEMBERS

5. ANNUAL RESOLUTIONS (7:03 PM)

The board discussed the pros and cons of continuing to hold elections and setting annual meeting dates in July. Mr. Winter will poll other districts and bring back further information regarding pros and cons. The board agreed at this time to leave those decisions in July.

Bruce Coleman made a motion to adopt the resolution establishing election of school board officers in July. Sheryl Wohler seconded. Motion carried 7-0.

Motion carried 7-0. Meeting recessed at 7:50 p.m. The meeting returned to open session at 8:05 p.m.

Principal Teri Dow of Central Elementary and Principal Amy Flinn of West Elementary schools presented an update of their current KESA goals and action plan.

14. BOE POLICY REVIEW—1ST READING (9:06 PM)

The board reviewed the current policy updates and discussed items pertaining to those updates. The policies will be approved on second reading at the February regular meeting.

In reviewing the pending policy revisions regarding physical restraint and bullying, Sheryl Wohler asked if the board could receive a report indicating a summary of how many times this occurs. Mr. Winter stated that we could provide a report after the buildings have submitted the information to the State.

The board discussed the negotiations team for 20-21 negotiations. Sheryl Wohler made a motion to appoint Cory Meyer, Deb Long and Terra Miller as the board negotiators. Rob Pettay seconded. Motion carried 7-0.
