DLM INFORMATION

- <u>DLM testing must take place in both fall and spring.</u>
- DLM blueprint requirements must be met during the fall testing window.
- The fall DLM testing window closes 12/22/23.
- KSDE's Cary Rogers was out to observe DLM administration in Rock Creek last year. It is possible she will be reaching out again to do site observations. We will contact you if this will be scheduled. This is an opportunity the state takes to ensure the DLM is administered to students who qualify.

RANDOM MOMENT TIME STUDY SURVEY - They began October 1, and for those of you who are new to this, the RMTS is a quick survey that is used to determine the amount of time spent on activities that are Medicaid related. You may or may not be selected for the RMTS. It is completely random. You must complete this survey. A list of those providers that have not completed the survey is sent out monthly to all directors in the state.

If you are selected for a RMTS you will receive an email from kssdac@pcgus.com approximately 5 days prior to your selected date and time of moment. Do not delete this email because it has the link you will need to complete your RMTS. You will receive additional reminder emails as the date approaches. You have 5 days after to complete the moment. If you do not complete the moment the day of, then you will also receive emails reminding you to complete it. 

NEW Para B & Para L Pay Rate

The Coop, with the support of the three school district superintendents, proposed an additional \$1.00 per hour for challenging duty pay (Para B & Para L). The proposal was approved at the 11/13/23 BOE meeting. With the pay period beginning on 11/5/23 the new challenging duty pay rate is now an additional \$2.00 per hour instead of \$1.00 per hour.

The maximum additional per hour increase with Para B and Para L pay is \$2.00 per hour. Though a para may have both Para B and Para L responsibilities in a given day, the time paid must be designated by Para B OR Para L. Accuracy of the Para B and Para L pay will be reviewed in August, November, January and March each year. It is the teacher's responsibility to monitor timesheets closely to affirm the correct pay code is being used in Skyward.

A para no longer qualifies for Para B or Para L challenging duty pay if the para moves from this position to one that is no longer serving high behavior or low incidence students. If the student moves, the student's needs change, or if the para's schedule changes, challenging duty pay discontinues. The case manager will notify the Director of Special Education and the Para Facilitator immediately so pay can be adjusted.

Indicator 8 Parent Surveys

As you know, each year KSDE does a survey of our parents/guardians who have a child(ren) with a disability on an IEP, to help us celebrate our strengths and make improvements as needed. All families with a student(s) on an IEP (excluding gifted) will be given the survey by the Coop. If the family has more than one child on an IEP, they fill it out only for the OLDEST child. The survey consists of one question: "Did the school district invite you to take part in discussion for improving services and results for your child?" The response is a yes/no response, followed by an open-ended opportunity for additional information to be shared. The survey will be open until May 31, 2024. Case managers, are you ready for some good news? The Coop has already sent out the survey to all families via email the end of August! The only thing we ask is that you mention this to families when you see them and/or have communication with them to remind them about the email with the survey and ask that they take a moment to complete it. Weekly communications, IEP meetings, P/T conferences, etc. would all be great opportunities to mention this survey to our families. Easy Peasy! THANK YOU for your help with this important discussion!

Now is a great time to review your caseload and remaining IEP due dates. Be sure to move up IEPs as needed to help ease the spring marathon. Reminder, the due date for all regular IEPs is April 12th. Only new placements, EC transitions, or move-in IEPs should take place after April 12. Looking ahead to fall 2024 IEPs, any annual IEP that is due on or before September 15 should be held in the Spring by April 12. Every team member in the Coop appreciates this so they are not scrambling with a beginning of the year IEP when students transition to them. Thank you for planning ahead.



Kansas Youth Empowerment Acedemy

KYEA is pleased to announce the 23rd Annual Youth
Leadership Forum for Students with Disabilities to be
nosted at Washburn University on July 15-20, 2024. They
are seeking your assistance in recruiting high school
juniors and seniors with disabilities who have
demonstrated an interest or potential for becoming
leaders. There is no cost for the student to attend this
five-day leadership and empowerment forum.

They are looking for high school juniors and seniors who have a disability, as well as students in an 18-21 transition program. They do not require that a student have an IEP, only that they have a self-identified disability and have demonstrated a capacity for developing leadership skills.

Progress Report Writing Reminders:

*Using "no data," "not enough data," "new IEP," or "new goal" is not an acceptable update for an IEP Progress Report. We are required to include the data we have at the time of the progress report. That could be O/5 attempts if no progress has been made YET. If the benchmark is for 50%, include where the student is at currently, which might be only 25%. KSDE requires us to report current actual data for the progress report, regardless if it's a new IEP/goal or limited data.

*The <u>"Status Date"</u> on the Progress Report <u>should be dated for the last day of the grading period NOT the date the report was written.</u> The progress report will be written shortly before/after that date and not more than one week after.

- Progress Reports MUST be written and put in Webkidss prior to leaving for break, for every student for every goal.
- Progress Reporting Dates must be no later than the end of the 2nd quarter dates for the districts which are as follows: USD 323: Dec 20th

USD 320: Dec 21st USD 329: Dec 21st

- Criterion in the goal updates must match the criterion in the baseline.
- Be sure that all of the dates and methods for when/how progress notes were provided to parents match. Related Service Providers please be sure to align your dates/times regarding dates/methods progress notes were given to parents with the dates/times entered by the case manager.
 - Progress reports <u>MUST</u> be written and sent home EVERY quarter and for the annual IEP if it's been more than 2 weeks since progress was updated.

- Progress report comments <u>MUST</u> be tightly aligned to IEP goals <u>AND</u> give specific data that shows progress or lack of progress.
- Progress reports <u>MUST</u> go home to families <u>EVERY</u> quarter and for the annual IEP if it's been more than 2 weeks since progress was updated.

NEW KSDE FORMS

The Special Education Notices/Forms Page, located within the KSDE website, has been updated to include 17 new language translations for the Parent Rights (Procedural Safeguards), Notice of Meeting and Prior Written Notice Model Forms, Revocation of Consent-Particular Service Sample Forms, and Revocation of Consent-All Services Sample Forms.

The languages include Amharic, Arabic, Burmese, Chinese, Chinese Traditional, Hmong, Lao, Nepali, Pashto, Pohnpeian, Polish, Portuguese-Brazilian, Russian, Somali, Swahili, Ukrainian, and Vietnamese.

Previously, these forms were only available in Spanish and English.

Loss of Plan Time

Plan time is critical and crucial in preparing for high quality lessons and IEPs. You all have done an outstanding job of creatively covering for each other to ensure colleagues get much needed plan time. Your efforts are very much appreciated! There are times when plan time is sacrificed due to a shortage in staff and/or student needs. Our top priority is to be sure to restore your plan time immediately, if it is missed. If plan time is being submitted for payment due to para shortage, you must be sure you have documented that you have reached out to Jennifer Nider to work towards finding a para sub. Visit with your principal ahead of time to problem solve together to determine how coverage for your plan time might be possible. If a teacher is submitting missed plan time regularly, the principal, teacher and Dr. Nauerth will work together to look at options for possible solutions to support the teacher getting their plan restored. If plan time is lost here is the procedure that will need to be followed for payment:

- 1. Contact Jennifer Nider to request a para sub.
- 2. Visit with your principal to discuss possible options for plan time coverage.
- 3. Thoroughly complete the new **Coop Loss of Plan Time Tracking Form**.
- 4. Have your principal sign the form.
- 5. Submit the form for each pay period due date to Deb, Teri and Robin.

After the form is submitted to the Coop, it will be reviewed by Dr. Nauerth and the Coop Board of Superintendents at their next meeting for approval. Upon approval, it will be sent to payroll to be included in the pay period appropriate based upon final submission timing.
